Agenda Item 1d — Announcement of Posted Location of Open Meetings Act

Following the Pledge of Allegiance, the Chair reported that a copy of the Nebraska Open Meetings Act had been posted in the rear of the room.

Agenda Item 1e — Recording of Notice of Public Meeting

The Chair then reported on the recording of the Notice of Public Meeting and stated the following:

1. Proof of Publication, pursuant to Policy 10503 of the Board of Governors, in the form of an affidavit of an employee of the Omaha World-Herald, to the effect that notice of this meeting was published in that newspaper on March 15, 2024, and on the Omaha World-Herald website Omaha.com from March 15-21, 2024.

2. Affidavit of College employee Julie Lanxon, to the effect that a copy of the published Notice of Meeting was transmitted to each member of the Board of Governors in a manner specified by Policy 10503 of the Board of Governors.

The notice of the meeting stated that an agenda for this meeting, kept continually current, was available for public inspection at the principal office of the Board of Governors, Building No. 30, 30th and Fort Streets, Omaha, Nebraska, by making prior arrangements by calling 531-622-2415.

Agenda Items 3a — Auditor Interviews

Monahan reviewed the process for interviewing the college auditor finalist candidate, Weaver and Tidwell, LLC., selected by the Board at the February Board meeting to be interviewed. The interview consisted of an opening statement by the firm, a questionand-answer session with the Board, and a closing statement by the firm. Following the interview, Monahan stated the Board would vote in open session.

Agenda Item 4 — Action Agenda

Agenda Item 4a — Consideration of Resolution Appointing the College Auditor for a Three-Year Period for Fiscal Years 2023-24, 2024-25, and 2025-26, Board Doc. 8013

BE IT RESOLVED that the Board of Governors of the Metropolitan Community College Area hereby appoints Weaver and Tidwell, L.L.P., as the auditor for the College's (1) Financial Statements and Student Financial Aid Programs, (2) Statement of Full-Time Equivalent(FTE)/Reimbursable Education Units(REU)/Reported Aid Equivalent Student Enrollment, and (3) Metropolitan Community College Foundation, for the fiscal years 2023-24, 2024-25, and 2025-26, with a College option to extend the contract annually for up to two additional fiscal years, per RFP 21624 bid documents.

Agenda Item 5 — Report Agenda

Agenda Item 5a — Ex Officio Board Members' Report

Student Ex Officio Representative Report

Zulu shared highlights from her written report, which featured the Student Advisory Council's strategies to meet their spring objective "to build meaningful connections with students" and Phi Theta Kappa's recent attendance at the Heartland Regional Spring Conference. The Board had no questions.

Faculty Ex Officio Representative Report

There was no faculty officio report.

Agenda 5b — Chair of the Board's Report

Monahan stated she attended MCC's 50th Anniversary Gala earlier this month and expressed it was a great celebration displaying how the college has grown from a startup to being a four-county community partner today.

Agenda 5c — Board Members' Reports

McDermitt, Reinhardt, and Ashby also commented on what a wonderful event the Gala was and thanked those involved with planning the event. Reinhardt expressed how he enjoyed seeing community members who believe in the college and have stood beside MCC on the climb upwards. Bruckner thanked Amy Recker, Associate Vice President for Advancement, for having the silent auction online so those not able to attend the Gala in person could participate from afar.

Agenda 5d — Presidents' Report

Schmailzl mentioned some recent news stories involving (1) Omaha Public Schools (OPS) Northwest High School and MCC's new dual enrollment program and (2) OPS and UNO's Middle College program being cancelled. OPS has been working with MCC's Secondary Partnerships to place the Middle College students in MCC's Gateway to College Program or offer them dual enrollment alternatives. Schmailzl mentioned the new Nebraska Statewide Workforce & Educational Reporting System (NSWERS) report on dual enrollment that he had forwarded to Board members earlier in the day.

Legislative Update

The list of bills the college administration has been monitoring was included in the Board packet. The Agency 83 appropriation for community college funding appears to be adding \$7-8 million to the community college pool to cover anticipated enrollment increases. If the college does not receive enough money, then taxes may be levied. Beginning this year, the state will distribute to each community college the amount distributed to the college the previous year plus either 3.5% or an increase equal to the percentage increase in reimbursable education units reported by the college, whichever is greater.

4918 N 30th Street Paving and Grading Bid Report

Administration reported back to the Board that a bid below \$250,000 has been accepted for the paving and grading at the recently cleared property on the corner of North 30th Street and Sorensen Parkway. Work is expected to begin this spring and be completed by summer's end.

Fremont Skywalk Removal

Schmailzl stated the Lenihan Skywalk (known as the Gerbil Run) connecting MCC's Fremont Area Center to the old Fremont High School will be demolished in April. Fremont Public Schools will pay for the demolition.

Agenda 5e — Regular Reports

No comments. No questions were asked.

Agenda 5f — Credential College Start-Up Report

Gary Girard, Vice President for Community and Workforce Education, presented his division's newest initiative, Credential College. This program offers non-credit workforce micro-credential training to upskill high school graduates who select alternative (non-college) pathways after high school. Credential College will build on the college's prior successes at the local and national levels, while providing students with proven training pathways to well-paying careers. The program is a scalable model that will build upon MCC's current workforce ecosystem. Girard answered Board members' questions. Several Board members expressed how they see this program helping build students' confidence and empowering them to recognize they can be successful and achieve their goals. Schmailzl added that the kickoff for this program is similar to how the college kicked off dual enrollment. Schmailzl stated some micro-credential areas being offered include: mobile device repair, phlebotomy, pharmacy technician, trades logistics, fiber optics, construction, and a customized Google program. Girard added that micro-credentials can be customized to work with community partners' needs.

Agenda 5g — Credit Program Modifications Report

Tom McDonnell, Vice President for Academic Affairs, provided an overview of the annual process to submit credit program modifications to the Nebraska Coordinating Commission for Postsecondary Education (CCPE). MCC's academic programs are reported to and approved by the Board of Governors, CCPE, Department of Education, and the Higher Learning Commission. McDonnell highlighted the CCPE's credit program definitions, the program proposal criteria, a new program proposal process, MCC's and CCPE's program reviews, and program modifications report. The Board annually approves the credit program modifications before they are submitted to the CCPE. McDonnell answered the Board members' questions.

Academic Advisor – The Academic Advisor engages students in discussions regarding career and academic interests toward developing a plan to realize their educational, career, and life goals. This position facilitates student understanding of degree and certificate requirements for academic transfer, vocational, and technical programs. (Alma Ramirez-Rodgers)

Exploratory Studies and Integrated Learning Skills Instructor – The Instructor teaches a full range of exploratory studies and academic success courses, and co-teaches alongside subject matter instructors to help students gain learning skills, literacy skills, and college success strategies as they learn program content. This position participates collaboratively in curriculum review and development, implementation of technology-based instructional strategies, outcomes assessment, advisory council activities, projects, and other department or College activities. Grant Coordinator – The Coordinator is responsible for all phases of grant and proposal development, including research, pre-award, post-award, and reporting. This position maintains grant compliance resources and builds relationships with constituents. (Derek Comba)

Success Navigator – The Navigator onboards new students from point of entry at the College. This position provides proactive, ongoing, individualized support assisting them through the complexities of the College environment. They connect students to services and resources and ensure students are on track with their individualized education plan. (Michaela Martin)

WHEREAS, the Board of Governors concurs that Ron Hug and Rick Sandvig should be recognized for their embodiment of the spirit, exemplary leadership, and contribution to the College and to the community that was exemplified by Don Wagner.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Governors of the Metropolitan Community College Area hereby awards the 2024 Don Wagner Award for Leadership and Service to Ron Hug and

Rick Sandvig in recognition of their outstanding leadership and service to both the College and to those it serves.

Agenda Item 8e — Consideration of Resolution Approving Extension of Lease Agreement for the College Central Stores, Board Doc. 8018

WHEREAS, the College's lease of space for its Central Stores at 1210, 1230-1234, and 1314-1322 East Hartman Avenue in Omaha is set to terminate on March 31, 2024; and,

WHEREAS, the College is in need of extending the Lease Agreement so it can continue to utilize the administrative and warehouse space as its Central Stores facility; and,

WHEREAS, College administration has negotiated a Second Addendum to the Lease Agreement with the Landlord for a five-year extension of the Lease Term, running through March 31, 2029, with an 8% increase in rent during the first year of the Renewal Term, and increases of 2% annually thereafter for the duration of the Renewal Term.

NOW THEREFORE BE IT RESOLVED by this Board of Governors that it approves the Second Addendum to the Lease Agreement for the College's lease of space for its Central Stores at 1210, 1230-1234, and 1314-1322 East Hartman Avenue in Omaha, extending the lease term for five additional years, through March 31, 2029, and authorizes the College President to execute said Second Addendum to the Lease Agreement with such modifications, changes, and amendments as the President, in consultation with College legal counsel, may deem appropriate and in the best interests of the College.

Agenda Item 8f — Consideration of Resolution Approving Sole Source Purchase of Renewal of Two-Year Colleague Cloud Hosting Agreement From Ellucian, Board Doc. 8019
